Introduction

As the Installed outdoor Children play & Open air gym equipments needs periodically maintenance for safety of the users & durability for which replacement of material fully or partly of the equipments whatever required to redress the public grievance for which selection of Agency / vendor is required for “Repair & Re-installation of existing equipment, replacement (where ever required) with Operation & Maintenance and upkeep of outdoor Child play & Open Air Gym equipments installed at different locations for a period of 3 years under Paradeep Municipality.”

1. BID PROCESSING FEE

₹10,000.00 (Rupees Ten Thousand only) towards cost of EoI documents should be in D.D /Banker Cheque in Favour of Executive officer, Paradeep municipality, Paradeep. EoI without payment of tender paper cost shall not be accepted in any case and will be rejected summarily. The cost of EoI paper is non-refundable.

2. EARNEST MONEY DEPOSIT (EMD)

- a. An Earnest Money Deposit (EMD) of rupees of ₹50,000.00 amount will be indicated in the Notice Inviting Tender should be in D.D /Banker Cheque in Favour of Executive officer, Paradeep municipality, Paradeep.

- b. Original manufacturer registered with Govt. are exempted, However, the agency has to claim with proper documentary support.(Original Manufacturing certificate by Govt.) DIC under MSME.
- c. Financial Proposals not accompanied by EMD shall be rejected as non-responsive.
- d. The EMD submitted along with the Proposal will remain valid for the period as mentioned in Notice Inviting Tender, including any extensions thereof.
- e. No interest shall be payable by the Client for the sum deposited as EMD.

4. Eligibility:

A. Eligibility:

- i. All Agency shall be deemed to have the nationality of India.
- ii. Agency shall be a registered Company/ Manufacturer and should have valid registration under Companies Act / Registered Firm / Proprietorship registered under State / Central Govt. authority in India / if any other (please provide a copy of the registration certificate).
- iii. The Agency should be in existence/ have been established for at least 5 years. Agency Firms should have minimum 3 years of experience in supply and installation of Children Playground Equipment and/ OR Open-Air Gymnasium Equipment.
- iv. Copy of constitution or legal status of the Agency as a manufacturer.
- v. Confirmation to the minimum technical specification of the equipment provided as per Annexure-1.
- vi. Certificate of Original Manufacture license registered under DIC, govt. of odisha.
- vii. Confirmation to Standard Terms and Conditions as per Appendix-4 of this document.
- viii. Any entity which is blacklisted by the Central Government, any State Government, a statutory authority or a public sector undertaking, as the case may be, and associate firms of such entity would not be eligible.
- ix. Bidder shall furnish an affirmative statement as to the existence of any potential conflict of interest on the part of the bidder due to prior, current, or proposed agreements, engagements, or affiliations with the Client. (Affidavit in non-judiciary stamp paper of ₹.100 - sworn in before the Executive magistrate, /Notary Public)

The bidder should demonstrate technical experience in relevant Government assignment (Central/ State/ Development Authority/ ULBs/Tourism department etc.) in the last 3 financial years preceding the Proposal submission due date, for Children Playground Equipment and / OR Open-Air Gym Equipment

The bidder must have supplied and installed the equipment as per the minimum technical specifications of each equipment mentioned in Annexure-I.

Note:-

1. Necessary supporting documents like Work Order, Letter of Award, Agreement and Completion Certificate should be submitted with the proposal duly signed under seal by authorized signatory.
2. The value of each completed projects should be certified by a Chartered Accountant in original shall be enclosed while submitting the bid with UDIN No.

A. Financial Eligibility:

- The bidder must have minimum turnover of Rupees 10 crore (Ten crore) in any one financial year of (2022-23, 2023-24, 2024-25) attached certified turnover certificate by CA for above financial year with UDIN No.

5. SCOPE OF WORK

The scope of work for “Repair & Re-installation of existing equipment, replacement (where ever required) with Operation & Maintenance and upkeep of outdoor Child play & Open Air Gym equipments installed at different locations for a period of 3 years under Paradeep Municipality”

THE SCOPE OF WORK INCLUDES

- * To provide onsite high quality preventive maintenance.
- * Repairing services using trained manpower.
- * Supply of best quality compatible parts and material.
- * Replacement of equipment if damaged and not repairable.
- * AMC include monthly preventive services, need-based repairing services, weekly basis maintenance of equipment and cleaning apart from attending to specific complaints.
- * Equipment shall be serviced periodically so that preventive action is taken for any possibility of malfunctioning/non-functioning of the same.
- * Complaints, if any, regarding malfunctioning/non-functioning of the equipment are to be attended expeditiously on call basis and in any case not later than 48 hours of lodging complaint.
- * Approved spare parts will be used by the agency as manufacturer’s specifications.
- * It will be availability the spare parts in stock.
- * Before filling the tender document, the bidder should inspect the physical fitness equipment installed at all location to familiarize himself with the various elements of services that are required to be rendered and to understand the quality levels of services that are required to be rendered.
- * Maintenance of complaint register and service register which to be certified by Engineering-in-charge in every week.
- * Auto Painting of all the equipment shall be done as soon as it got faded subject to minimum once in a year.

* Mechanical structure may be changed or repaired by welding, cutting & grinding if it needs. Even main structure gets rust or out of order; it must be replaced or renovated by using rod, pipe or any other metal parts.

* The Equipment not repairable in position the same will be replaced anew equipment which cost only of the equipment will be paid to the bidder as per approved rate of same equipment's.

The cost of materials change during maintenance period will be paid once in a 2 years, (due to saline atmosphere) further if required to change the materials the agency will be bear within the AMC cost.

6. Site Visit:

The Agency may visit and examine the location sites and its surroundings and to submit the certificate towards visit along with engineer-in-charge at the time of submission of tender and obtain for himself all information that may be necessary quoting rates at his cost and responsibility of any clarification in this regard may contact office during office hour of working days.

7. History of Litigation and Criminal Record:

If any criminal cases are pending against the Bidder (him/her/partners) at the time of submitting the tender, then the tender shall be summarily rejected.

8. Amendment/modification in EOI

At any time prior to deadline for submission of proposal Paradeep Municipality may for any reason modify the EOI document by issuance of amendment/addendum. Such amendments shall be posted on the office website.

9. Modifications and Withdrawal of Proposals

No modifications to the Proposal shall be allowed once it is received by Paradeep..

10. Other Requirements:

- i . Even if the Bidder meet so their criteria, his tender shall be summarily rejected if he is found to have mislead or made false representation in the form of any of the statements submitted in proof of the eligibility and qualification requirements.
- ii. The tender shall also be summarily rejected, if he has are cord of performance such as absconding from work, works not properly completed as per contract.
- iii. In addition to the above, even while executing the work, if it is found that he produced false/fake, certificates in his tender, he will be blacklisted.

11. Original Certificates:

Original documents/certificates shall be produced as and when required to verify the copies of statements and other information furnished along with tender. Failure to produce original documents in time will lead to disqualification.

12. Proposal Opening

A. The technical proposal shall be opened on the due date & time and will be evaluated first.

- Bids received on line shall be opened in the office of the undersigned in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the Office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- The Financial Proposals of only those firms fulfilling the eligibility criteria and the technical requirements of the Proposal shall be opened. The date and time of opening of the Financial Proposals will be intimated to the qualifying Bidders later.

13. EVALUATION OF BID

Offers received in response to this invitation would be evaluated as mentioned under-

- i) The offers shall be scrutinized to evaluate whether they meet the eligibility criteria and requirements of the authority as specified in this EOI.
- ii) The eligible offers shall be then evaluated in terms of their relevant experience and capability to carry out the assignment and deliver desired outcomes, and shall be assigned technical score.
- iii) The offers shall be assigned Technical Score (TS) out of 100 marks as per the marking scheme presented below.
- iv) The Authority intends to shortlist offers of the bidder having qualifying Technical Score more than 70% of total marks shall be considered for Short listing.
- v) The Short-listed Agencies shall be empanelled for a period of three years for consideration for executing above assignments, the authority may extend the period of empanelment.
- vi) The empanelled agency will be issued NIT/ RFP by the respective ULBs based on the requirement and as per scope of work relating to specific requirements Proposal.

All the Bids received in response to the notice for tender will be scrutinized by the Evaluation Committee by Paradeep Municipality.

Process: Phase-I:

Technical Evaluation: Detailed evaluation process as per the following parameters will be adopted for evaluation of the technical proposals.

All the proposals received will be scrutinized to assess their eligibility based on the Qualifying criteria. Those proposals which do not meet the qualifying criteria will be rejected forthwith at any stage of detection.

Opening of Financial Bid:

The Financial Proposals of only those firms fulfilling the eligibility criteria and the technical requirements of the Proposal shall be opened. The date and time of opening of the Financial Proposals will be intimated to the qualifying Bidders later.

14. The Service Agreement-

A Service Agreements (SA) shall be entered into by and between the Executive officer, Paradeep Municipality and the respective successful Agency at the operative stage for maintenance. The Work order will be issued to the selected agency as per requirement from time to time.

15. Contract Negotiation-

Contract negotiation, if required will be held at a date, time and address as intimated to the selected bidders). The bidder will as a pre-requisite for attendance at the negotiations, confirm availability of all the proposed staff for the assignment. Representative conducting negotiations on behalf of the bidder must have written authority to negotiate and conclude a contract. Negotiation will be performed covering financial aspects. If any and availability of proposed professionals etc.

16. MINIMUM MANPOWER AND MACHINERIES TO BE DEPLOYED

- i. Manpower: The selected Agency shall always employ experienced staff with technical knowledge as per requirement.
- ii. Machineries: Grinding Machine - 2, Welding Machine-2, Cutting machine -2, Drilling Machine-1, Portable Generator Set (instant repairing at park site)

17. Payment Terms

- The payments will be made by Executive officer, Paradeep Municipality (subject to deduction of statutory taxes and levies, if any) as follows:
- The total duration of the contract shall be 36 (thirty-six) months (Contract Period) and may be extended on the same terms & conditions, Payment shall be made on monthly basis. Payment will be made monthly on submission of Invoice in duplicate to the employer as per the agreed terms and conditions.
- The agency shall at its sole expense and risk, carry out the repair and maintenance work.
- The agency shall carry out the repair and maintenance at the locations provided in strict compliance with all applicable laws.
- The Selected Bidder shall be solely responsible and liable, at his own cost, for all maintenance, upkeep and repairs of the equipment's and its entire components.
- Items will be executed or order as per requirement and payment will be made lowest rate of each items to the Agency
- Payment made as per actual work done and no of equipment repaired and colored and duly verified by Engineer In-charge.

18. Penalty

The SELECTED BIDDER shall bear the cost of day-to-day repairs and maintenance. All repairs needed for smooth functioning of outdoor gym equipment and it shall be the responsibility of Selected Bidder. If the repairs or maintenance required to be carried out by Selected Bidder are not carried out within reasonable time, the Selected Bidder will have to go through the penalty. The agency will provide the name and Phone Number of his responsible person to attend the. On receipt of the complaint, the agency has to take-up the repair work of the defective equipment's at various parks within 72 hours.

19. TERMINATION

Paradeep Municipality reserves the right to terminate the Agreement proposed to be executed with the successful party with 30 days written notice to successful bidder in the event of:

- i. The successful bidder violates any clauses applicable to this EOI;
- ii. Unsatisfactory performance by the successful bidder at any time during the contract Period.
- iii. Misrepresentation with regard to any information at any time during the contract Period.
- iv. The EMD/Security Deposits will be forfeited in case of condition mentioned above and if the selected Agency show unwillingness to execute after Agreement is signed.

20. DISPUTE RESOLUTION

In the event, any dispute arises between the successful bidder and Paradeep Municipality in Connection with this tender, the interpretation of any provision of this tender or the rights, Duties or liabilities of the successful bidder/ Paradeep Municipality under this tender; same shall be referred to a sole Arbitrator to be jointly appointed by the Paradeep Municipality and the Agency. In the event disputes are not resolved even after appointment of Arbitrator either of the Parties Shall be free to approach appropriate court of law. The Courts in Jagatsinghpur alone have the Exclusive jurisdiction in respect of all disputes in relation to this tender.

21. GENERAL TERMS & CONDITIONS

- The bidder shall submit detailed work plan daily routine works.
- The Bidders shall be responsible for all of the costs associated with the preparation of their Bids and their participation in the Bidding Process. Paradeep Municipality shall not be Responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.
- It shall be deemed that by offering a Bid, the Bidder has:
 - Made a complete and careful examination of the bidding documents, visited the site, received all relevant information from Paradeep Municipality at his own cost.
 - Satisfied itself about all matters, things and information hereinabove Necessary and required for bidding, execution of the agreement in accordance with the bidding documents and performance of all of its obligations there under.
 - Acknowledged and agreed that ignorance of any of the matters herein above Shall not be a basis for any claim for compensation, damages, claim for Performance of its obligations, loss of profits, etc. from Paradeep Municipality. Agreed to be bound by the undertakings submitted by it under and in terms Hereof.
- Any corrigendum including extension of date or change of date for submission of the Tender shall be published on the website and that shall be deemed to have been seen by the bidders.
- Final selection of Agency from the bid received will be done at the discretion of Paradeep Municipality and the decision of Paradeep Municipality shall be final and binding on all the participating parties.
- The Agency must execute an Agreement with Paradeep Municipality to fully protect Paradeep Municipality overall interests and also the interests of the Agency.
- On expiry of the said Agreement or on its termination for any cause whatsoever, the Agency shall vacate the premises and hand over the peaceful possession to the Paradeep Municipality.
- The prayer for renewal, if any, shall be considered on satisfactory performance of the Agency. In that case, the incorporation of any additional terms and conditions in the Mode of Operation will be decided by the Paradeep Municipality.
- The Agency shall not make any addition or alteration within the scheduled premises without any explicit, written permission of the Paradeep Municipality.
- The Agency will have to commence the repair works within 10 days from the date of handing over the possession, otherwise the Paradeep Municipality will have right to terminate the Agreement.
- The Agency shall not be permitted to use the common areas of the Park for conducting. Any form of business other than tools, machines and spares' storage purposes. Common areas shall not be blocked or encroached upon in any way whatsoever.

- The Bidder will have to make his own arrangements for electricity or if in case the same being provided by Paradeep Municipality then the contractor shall install a meter and pay their use to the Paradeep Municipality as per TPWODL Tariff.
- At any time prior to deadline for submission of proposal Paradeep Municipality may for any reason modify the EOI document by issuance of amendment/addendum. Such amendments shall be posted on the website.
- Any damage to the Paradeep Municipality property caused during the maintenance operation shall be made good or compensated by the Bidder.
- The Bidder shall maintain and update all records of labour employed for this work and produce the same to the Engineering-in-charge on daily basis and any other Competent Authority as and when required.
- Bidder will be not permitted to construct any permanent structure for above purpose without the permission of the Authority.
- Persons to be engaged by the bidder for watch and ward should be well behaved to the public.
